## (A) PREAMBLE:

The Nigerian Institute of Medical Research Yaba, Lagos invites interested competent and qualified contractors to tender for the following projects in the institute.

#### (B) PROJECTS:

#### THE PROJECTS INVOLVED ARE AS FOLLOWS:

- (1) **LOT 1**: Construction of 2-storey building for offices and board room.
- (2) **LOT2:** Rehabilitation of 3-storey building for research laboratories.

## (C) Scope of Projects:

- (3) Evidence of Current Audited Accounts for the last three (3) years 2015, 2016, 2017.
- (4) Evidence of certificate of compliance with the pensions reform (PENCOM).
- (5) Evidence of contribution to Industrial Training Fund (ITF).
- (6) Sworn affidavit indicating whether any staff of the Nigerian Institute of Medical Research is a former or present Director, Shareholder or has any pecuniary interest in the company.
- (7) Evidence of financial capability and bank reference.

- (8) List of personnel to be deployed to the projects showing qualifications and experiences.
- (9) List of equipment (owned/hired) and technical capacity.
- (10) A verifying affidavit under the public procurement Act 2007 sworn to at the Federal High Court indicating that the company is not in receivership and none of the Directors has been convicted for fraud.
- (11) Verifiable list of similar jobs carried out by the firm in the last five (5) years, including cost.
