(a) Disclosing whether or not any officer of the relevant committees of Federal Government College, Warri or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars,

(b) The company is not in receivership, insolvent or bankrupt, and

(c) The company has any Director who has ever been convicted in any court in Nigeria or any other country for criminal offences in relation to fraud or financial impropriety,

(viii) Evidence of Financial Capability to execute the job, by submission of Reference Letter from a reputable commercial Bank with willingness to provide credit facility for the execution of the project when needed.

(ix) Company Profile with the Curriculum vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (ARCON, COREN, QSRBN, CORBON, etc),

(x) Verifiable documentary evidence of at least (3) similar job(s) successfully executed in the last five (5) years including Letters of Awards, Valuation Certificates and/or Job Completion Certificates and Photographs of the projects,

(ii) Contractors are not permitted to bid for more than One (1) lot. Any bidder that violates this rule shall be disqualified, and only successful bidders will be invited for the next stage of the bidding process,

(iii) Only Pre-qualified bidders at Technical evaluation will be invited at a later date for the Financial Bid Opening, while bids of unsuccessful contractors will be returned un-opened,
