(k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five
(5) years including letters of Awards, Valuation Certificates, Job completion certificates and photographs of the projects.

(I) List of Plants/Equipment with proof of Ownership/Lease. (where applicable).
