ELIGIBILITY

- (ix) Evidence of Registration with ITF;
- (x) Evidence of Registration with BPP (IRR)
- (xi) Evidence of Registration with NSITF;
- (xii) Evidence of Financial capability
- (xiii) A sworn affidavit that all the documents attached are correct and genuine documents
- (xiv) A sworn affidavit that no official of the Hospital has any business relationship with the company

COLLECTION OF TENDER DOCUMENT
