 shareholder or has any pecuniary interest in the bidder and to confirm that all information
 presented in its bid are true and correct in all particulars;

- That the company is not bankrupt, in receivership or under liquidation or involved in any litigation which can potentially affect the company's ability to effectively discharge their responsibility if engaged;
 - (h) Letter of Authorisation from the original manufacturers as contained in Approval Policy for procurement of Health and Medical Equipment for Tertiary Hospitals in Nigeria;
 - (i) Company's Audited Accounts for the last three (3) years (2016, 2017, and 2018);
 - (j) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria indicating willingness to provide credit facility for the execution of the project when needed;
 - (k) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications;
 - (I) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five
 (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;
