(1) INTRODUCTION

The Lagos University Teaching Hospital, Idi-Araba intends to procure Patients' Lifts to facilitate the transfer of patients to various Wards and drugs for her Pharmacy Department. Experienced and competent contractors/suppliers are invited to submit bids for the installation of the Patients' Lifts and Procurement of Drugs tor the Hospital's Pharmacy Department.

(2) SCOPE OF SUPPLY

Lot 1: Installation of the Patients' Lifts

Lot 2: Procurement of Drugs for the Hospital's Pharmacy Department

(3) ELIGIBILITY REQUIREMENTS

- (a) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Form CAC2 and CAC7;
- (b) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years (2015, 2016 & 2017) valid till 31st December, 2018;
- (c) Evidence of current Pension Compliance Certificate valid till 31st December, 2018;
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2018;
- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2018;
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate Issued by BPP.
- (g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Lagos University Teaching Hospital or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder, that the company is not bankrupt, in

receivership or under liquidation or involved in any litigation which can potentially affect the company's ability to effectively discharge their responsibility if engaged and to confirm that all Information presented in its bid are true and correct in all particulars;

- (h) Evidence of registration with Pharmacists Council of Nigeria (Lot 2);
- (i) Company's Audited Accounts for the last three (3) years (2015, 2016 & 2017);
- (j) Evidence of financial capability to execute the project including Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- (k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;
- (I) All documents tor submission must be transmitted with a Covering/ Forwarding letter under the Company/Firm's Letter Head Paper baring amongst others, the Registration Number (RC) as Issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(4) COLLECTION OF TENDER DOCUMENTS

Interested companies are to collect the Standard Bidding Document (SBD) from the office of the Assistant Director, Procurement, Room 04, Third Floor, Health Records Officers Registration Board of Nigeria Building, LUTH on evidence of payment of a non-refundable fee of N10,000.00 per Lot, paid into the Lagos University Teaching Hospital's Remita account in any commercial bank.

(5) SUBMISSION OF TENDER DOCUMENTS

Prospective bidders are to submit bid for each of the Lot desired, two (2) hard copies each of the technical and financial bids with softcopy of financial bid only in MS Excel format, packaged separately in sealed envelopes and clearly marked as "Technical Bid" or "Financial Bid". Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to The Chief Medical Director, Lagos University Teaching Hospital, Idi – Araba and clearly marked with the name of the project and the Lot number. Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and dropped in the designated Tender provided in the office of the Assistant Director, Procurement **not later than 12:00 Noon Monday 12 November, 2018.**

(6) OPENING OF BID

The technical bids will be opened immediately after the deadline for submission **12:00Noon Monday 12, November, 2018** in the Old Board Room, LAGOS UNIVERSITY TEACHING HOSPITAL, IDI – ARABA in the presence of bidders or their representatives, while the Financial bids will be kept unopened.
