- (b) Verifiable evidence of Tax Clearance Certificate in the last three years: 2016, 2017 and 2018.
- (c) Verifiable evidence of current Pension Commission (PENCOM) compliance clearance Certificate (2019)
- (d) Verifiable evidence of current clearance certificate from Industrial Training Fund (ITF) (2019)
- (e) Verifiable evidence of compliance with Registration with National Social Insurance Trust Fund (NSITF)
- (f) Verifiable evidence of registration with the Bureau of Public procurement (BPP) federal contractors, consultants and suppliers Database

- (g) Verifiable evidence of financial support from a reputable Bank
- (h) Verifiable evidence of similar works successfully executed, at least three in the past five years, with names of clients, award letters and job completion certificate
- (i) Verifiable evidence of construction equipment with proof of ownership or lease agreement
- (j) Verifiable evidence of a non-refundable tender fee of N10,000.00
- (k) Verifiable evidence of company profile
- (l) A sworn Affidavit confirming that all information presented and attached are true and correct, that the company is not under receivership, insolvency or bankruptcy and that none of its Directors was ever convicted by any court of law or staff of the Federal Ministry of Education (FME) or BPP.
