- (iv) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable Commercial Bank indicating willingness to provide credit facility for the execution of the project when needed.
- (v) Audited account of company for two (2) years.
- (vi) Evidence of payment of a Non-refundable Tender Fee of N100,000.00 (One Hundred Thousand Naira only) made in Certified Bank Draft in favour of "Medical and Dental Consultants' Association of Nigeria" Or Bank transfer to:
