- (iii) Current Pension Compliance Certificate expiring on 31/12/2019.
- (iv) Current ITF Compliance Certificate expiring on 31/12/2019;
- (v) Current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate expiring on 31 /12/2019;
- (vi) Registration of the National Database of Contractors, consultants and suppliers by submission of Interim Registration Report (IRR) expiring on 31/1/2020 or valid Certificate issued by the Bureau of Public Procurement (BPP);
- (vii) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal Science and Technical College, Awka or the Bureau of Public procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in the bid are true and correct in all particulars;
- (viii) Company Audited Accounts for the last three (3) years (2016, 2017 and 2018).
- (ix) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility forthe execution of the project when needed.
- (x) Company profile and evidence of Technical Qualification of key persons including copies of Academic/Professional Qualifications such as COREN, QSRBN, ARCON, CARBON etc (for works)
- (xi) Verifiable documentary evidence of at least three (3) similar job(s) successfully executed in the last five (5) years including letters of awards and job completion certificates.
- (xii) List and verifiable evidence of construction equipment with proof of ownership or lease agreement.
- (xiii) All document for submission must be transmitted with a covering/ forwarding letter under the company's Letter Head paper bearing amongst others, the Registration number (RC) as issued by the Corporate Affairs Commission(CAC), Contact Address, Contact Telephone numbers, valid e-mail address and official company's address, The letter Head paper must bear the Name, Nationalities and the telephone numbers of the Directors of the Company at the bottom of the page, duly signed by authorised officer of the firm.
