#### **INVITATION TO TENDER FOR THE EXECUTION OF CAPITAL PROJECTS UNDER THE 2018 APPROPRIATION ACT FEDERAL NEURO PSYCHIATRIC HOSPITAL, KWARE-SOKOTO**

##### **(1.0) INTRODUCTION**

The Federal Government of Nigeria has allocated funds to the Federal Neuro Psychiatric Hospital, Kware-Sokoto in the 2018 Appropriation Act for the execution of policies, programmes and projects towards achieving the mandate of the Hospital. The Hospital therefore invites interested reputable contractors with relevant proven competence and experience to submit Tender for the execution of the projects below:

##### **(2.0) SCOPE OF THE PROJECTS**

Interested Contractors are invited to submit technical and Financial Bid for the following:

The scope of the above mentioned projects are detailed in the bidding documents, which will be issued to interested bidders.

##### **(3.0) ELIGIBILITY OF REQUIREMENTS**

Prospective bidders must meet the under-listed requirements to be eligible to participate in this procurement:

(i) Evidence of registration with Corporate Affairs Commission (CAC) by inclusion of Certificate of Incorporation, Form CAC<sub>2</sub> AND CAC<sub>7</sub>;

(ii) Evidence of Tax Clearance Certificate for the last three (3) years valid till 31<sup>st</sup> December, 2018; corresponding with the declared Annual Turnover in the Audited Accounts;

(iii) Evidence of current Pension Compliance Certificate valid till 31<sup>st</sup>, December, 2018;

(iv) Evidence of current Industrial Training Fund (ITF) Compliance certificate valid till 31<sup>st</sup> December, 2018.

(v) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) compliance certificate valid till 31<sup>st</sup> December, 2018;

(vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by the Bureau of Public Procurement (BPP);

(vii) Companies Audited Accounts for the last three (3) years – 2015, 2016, 2017

(viii) Evidence of Financial capability to execute the project submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;

(ix) Company's Profile with the Curriculum Vitae of Key Staff to be deployed for the Projects including copies of their Academic/Professional qualifications: COREN, QSRBN, ARCON, CORBON;

(x) Verifiable documentary evidence of at least three (3) similar projects executed in the last five (5) years including Letters of Awards, Valuation/Interim Payments Certificates, Job Completion Certificates and Photographs of the Projects;

(xi) List of Plants/Equipment to be used with the proof of ownership, license or lease agreement (where applicable);

(xii) A sworn Affidavit disclosing that:

- No partner/director has ever been convicted in any country for criminal offences related to fraudulent or corrupt practices;
- Whether or not any officer of the relevant committee of the Federal Neuro- Psychiatric Hospital, Kware, Sokoto or BPP is a former or present director of the company and that all the documents submitted are true and correct in all Particulars.
- The company/firm is not in receivership insolvent or bankrupt;
- The proposed goods to be supplied will possess Mandatory Conformity Assessment Programme (MANCAP) certificate issued by Standard Organization of Nigeria (SON).

(xiii) For Joint Venture/Partnership, Memorandum of Understanding (MOU) should be provided (all the eligibility requirements are compulsory for each JV partner);

(xiv) All documents for submission must be transmitted with a Covering/ Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GS No.), and e-mail address. The Letter Head Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of company/ firm.

#### **(4.0) COLLECTION OF BIDDING DOCUMENTS**

Interested and competent bidders are to collect the Standard Bidding Document (SBD) from the Office of the Procurement Officer, Admin Block, Federal Neuro-Psychiatric Hospital, Kware, No.1 Kware Illela Road, Kware, Sokoto State, upon presentation of evidence of payment of non-refundable tender fee of N10,000.00 per Lot, Paid into the Federal Neuro-Psychiatric Hospital, Kware, Sokoto's Remita's account in any reputable commercial bank in Nigeria.

#### **(5.0) SUBMISSION OF BIDDING DOCUMENTS**

Prospective bidders are to submit bid for each of the Lot desired, two (2) hard copies each of the technical and financial bids with softcopy of financial bid only in MS Excel format, packaged separately in sealed envelopes and clearly marked as "Technical Bid" or "Financial Bid". Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to The Medical Director, Federal Neuro-Psychiatric Hospital, Kware, No.1 Kware Illela Road, Kware, Sokoto State, P.M.B. 2196, Kware, Sokoto and clearly marked with the (the name of the project and the lot number). Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and be deposited in the designated Tender Box at the office of the Procurement Officer between hours 9am-3:30pm Monday-Friday **not later than 12:00 noon on Monday, 10 December, 2018.**

#### **(6.0) OPENING OF BID**

The technical bids will be opened immediately after the deadline for submission at **12:00noon on Monday, 10 December, 2018** in the Bafarawa Hall, Federal Neuro-Psychiatric Hospital, Kware, Sokoto in the presence of bidders or their representatives, while the Financial bids will be kept un-opened. Please ensure that you sign the Bid Submission Register in the office of the Procurement Officer, Admin Block, Federal Neuro-Psychiatric Hospital, Kware, No.1 Kware Illela Road, Kware, Sokoto State, as the Hospital will be held liable for misplaced or wrongly submitted bids. - (a) All bids must be paginated and items required in the eligibility criteria to be arranged in the order of sequence as listed above;
- (b) Bids must be in English language and signed by an official authorized by the bidder;
- (c) Bids submitted after the deadline for submission would be returned un-opened;
- (d) Bidders should not bid for more than two (2) Lots;
- (e) Submission that do not meet up with the requirements specified above shall rejected;
- (f) All cost will be borne by the bidders;
- (g) All pre-qualified bidders will be contacted at a later date for financial bid opening, while bids of un-successful bidders will be returned un-opened;
- (h) The Federal Neuro-Psychiatric Hospital, Kware, Sokoto is not bound to prequalify any bidder and reserves the right to annual procurement process at any time without incurring any liabilities in accordance with Section 28 of the Public Procurement Act 2007.
