Interested and competent contractors, suppliers wishing to carry out this required to submit their Company profiles, which shall include the following:

- (ii) Evidence of filing Company's Annual returns to CAC for year 2017;
- (iii) Evidence of Tax clearance Certificates for the past three years (2015, 2016and 2017) valid till 31 December 2018;
- (iv) Evidence of Current certificate of Compliance by National Pension Commission (PENCOM) valid till 31 December 2018.
