(b) Evidence of Company's Income Tax Clearance Certificate for the last three (3) years valid till 31st December 2021;

- (c) Evidence of current Pension Clearance Certificate valid till 31st December 2021;
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December,= 2021;

(e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Clearance Certificate valid till 31st December 2021;

(f) Evidence of Registration on the National Database of Federal Contractors, Consultants, and Service Providers by submission of Interim Registration Report (IRR) expiring on 31/12/2021 or valid Certificate issued by BPP.

(g) Sworn Affidavit:

- disclosing whether or not any officer of the relevant committees of the Federal Medical Centre, Ebute- Metta, Lagos State or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- None of the Directors of the company has ever been convicted by any Court of Law;
- The Company is not bankrupt or a party to liquidation proceedings in any Court
- Company's Audited Accounts for the last three (3) years -2018,2019 & 2020;

(h) Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;

(i) Company's Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: COREN, QSRBN, ARCON, CORBON etc.);

(j) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;

(k) Works: List of Plants/Equipment with proof of Ownership/Lease;

(I) Lot G: Evidence of current registration/accreditation with Computer Professionals Registration Council of Nigeria (CPN) and National Information Technology Development Agency (NITDA);

(m) Letter of Authorization from the Original Equipment Manufacturers listed in the Approved Policy for Procurement of Health and Medical Equipment for Tertiary Hospitals in Nigeria, for bidders of Lots D, F, H & I

(n) Lot J: Evidence of current Registration with Nigerian Electricity Management Services Agency (NEMSA);

(o) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

#### (4.0) COLLECTION OF TENDER DOCUMENTS

Interested Companies are to collect Bidding Documents at the Procurement Department of the Hospital on evidence of payment of a non-refundable tender fee of N10,000.00, paid into the Federal Medical Centre, Ebute-Metta, Lagos Remita Account in any reputable commercial bank in Nigeria.

(iii) All documents should be dropped in the Tender Box located in the office of the HEAD OF PROCUREMENT not later than 12:00 noon on Monday, 19 July 2021.

#### (6.0) OPENING OF TECHNICAL BIDS

The Technical bids will be opened immediately after the deadline for submission at **12:00noon on Monday**, **19 July 2021** in the Seminar Room, Federal Medical Centre, Ebute-Metta, Lagos.
