- (vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP;
- (vii) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the University of Benin Teaching Hospital or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder, that the company is not bankrupt, in receivership or under liquidation or involved in any litigation which can potentially affect the company's ability to effectively discharge their responsibility if engaged and to confirm that all information presented in its bid are true and correct in all particulars;
- (viii) Company's Audited Accounts for the last three (3) years (2015.2016 & 2017);

- (ix) Evidence of financial capability to execute the project including Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- (x) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;
- (xi) Only local manufacturers/assemblers of vehicles approved by the National Automotive Design and Development Council or their authorized dealers are eligible to bid for lot 13 (Supply of 1 No. Refuse Truck);
- (xii) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (Lot 11 & 12: COREN, QSRBN. ARCON. CORBON etc.);

Evidence of payment of non-refundable fee of N10.000.00 (ten thousand naira) only per lot made through the Remita Platform to the University of Benin Teaching Hospital at any Commercial Bank in Nigeria must be presented before collection of the Tender Documents. Please note that bidders for Lot 14 are not required to pay for collection of tender document except when prequalified.

## (5.0) SUBMISSION OF TENDER/ PREQUALIFICATION DOCUMENTS

For Lots 1-13. tender documents are to be enclosed in two separate envelopes, one to contain the Technical Bid and boldly marked '**Technical Bid**' on the top right corner, and the other to contain the Financial Bid and boldly marked '**Financial Bid**' on the top right corner. Prequalification documents/bids received after the respective deadlines stated shall not be considered. All submissions must be made in English Language.

Bidders or their representatives. Civil Society Organizations, Non-Governmental Organizations and other interested members of the public are invited to witness the opening of the technical bids. Prequalified bidders shall be notified in writing to tender for project Lot 14 on a later date.
