(vi) Evidence of Registration on the National database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on date 01/01/2019 or valid Certificate issued by BPP;

(vii) Evidence of being a Manufacturer Representative for Medical Equipment;

(viii) Sworn Affidavit;

(a) Disclosing whether or not any officer of the relevant committees of the IRRUA SPECIALIST TEACHING HOSPITAL or the Bureau of public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars;

(b) That the company is not in receivable, insolvent or bankrupt, and

(c) The company has any Director who has been convicted in any court in Nigeria or any other country for criminal offences in relation to fraud or financial impropriety;
