(1) The Kaduna State Government has received a credit from the International Development Association toward the cost of HIV/AIDS Program Development Project – II, and it intends to apply part of the proceeds of this credit to payments under the Contract for the Procurement of Test Kits, Contract No.. KADSACA/HPDP II/GOODS/NCB/01/15.

(2) The *Kaduna State Second HIV/AIDS Program Development Project (HPDP II)*, now invites sealed bids from eligible and qualified bidders for **Procurement of Test Kits.**

(3) Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines; Procurement under IBRD Loans and IDA Credits, and are open to all bidders from Eligible Source Countries as defined in the Guidelines.

(5) Qualifications requirements include: Evidence of Registration with Cooperate Affairs, Manufacturer Authorization, Power of Attorney Warranty Period, Evidence of experience in similar project executed, Audited Financial Statement and Tax Clearance. A margin of preference for certain goods manufactured domestically “shall not” be applied. Additional details are provided in the Bidding Documents.

(6) A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non -refundable fee of N20, 000 only in a freely convertible currency and in form of cash or Bank Draft payable to the Kaduna State HIV/AIDS Program Development Project (HPDP II). The Bidding Documents after completion should be delivered directly in the Bid Box.

(7) Bids must be delivered to the address below **on or before 11am on 22nd December, 2015** in the Bid Box. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at the address below at **12.00noon on Tuesday 22nd December, 2015**.

All bids must be accompanied by a “*Bid Security*” *not less than 2.5% of Bid Price*.
