# Invitation for Expression of Interest (EOI) for Supply of Diesel for Rigs Oritsetimeyin & Onome

# **INTRODUCTION:**

The Receiver/Manager, in management of Seawolf Oilfield Services Limited (In Receivership) ("Seawolf') by reason of his appointment by Asset Management Corporation of Nigeria ("AMCON), is desirous of engaging persons or corporate bodies experienced in and capable of supplying diesel meeting relevant specification for the proper working of its drilling rigs Oritsetimeyin and Onome now at the Marina jetty, Lagos or anywhere else they may be located.

## **EXPRESSION OF INTEREST:**

(a.) The Receiver/Manager hereby invites interested companies to submit their expression of interest in pre-qualification for the supply of diesel to Rigs Oritsetimeyin and Onome.

# COMPANIES ARE TO MEET THE FOLLOWING REQUIREMENTS:

(a.) The company must be able to supply 100,000 litres of diesel in one bulk.

(b.) The company must be able to meet all other conditions precedent to a successful delivery of diesel to the rigs including procurement of Naval Clearance and other relevant permits.

(c.) Diesel delivered must conform to specifications and standards and if not met, Receiver /Manager will have the right to reject the delivery.

(d.) The company must comply with all legal standards and compliance.

(e.) Diesel supplied for use in Rigs Oritsetimeyin and Onome must meet the specifications of Standards Organization of Nigeria ("SON"), and Department of Petroleum Resources ("DPR") etc.

(f.) The company must have the capacity to be able to make delivery on the Rigs Oritsetimeyin and Onome currently located at Marina CMS by Ferry Terminal where the Water Current is at 22 knots in high tide and 17 knots in low tide.

#### SUBMISSION OF EXPRESSION OF INTEREST:

Interested companies are required to submit the following information:

Expression of Interest should be submitted in a sealed envelope with 1(one) original and 5 (five) copies along with 1 (one) soft copy contained in USB storage device with the envelope clearly marked "EXPRESSION OF INTEREST FOR SUPPLY OF DIESEL" delivered to the Receiver/Manager at the address stated below, **not later than 4pm Nigerian time, on the 19th day of December, 2016.**

(b.) Only companies which submit the required information and meet the pre-qualification criteria will be contacted to participate in the RFP and Transaction Process.
