### (A) SCOPE OF WORK

# The scope of work covers both pre and post contract consultancy services which includes but not limited to;

- (1) The preparation of preliminary designs and estimates
- (2) Advising on cost alternatives
- (3) Production of detailed working drawings

(4) Production of detailed Bills of quantities, Article of agreement and analyzing and providing Tender reports

(g) Evidence of compliance with the provision of Industrial Training Fund (ITF) Amendment Act by inclusion of compliance Certificate from (ITF)

(h) Verifiable evidence of having successfully provided consultancy services (designed ad supervised) similar work in the past, name of client, location of projects, contract sums, letters of engagements and photographs

(i) Evidence of Financial capability and banking support to undertake the project

(j) Company profile with names and qualifications of key technical and administrative personnel to be used (Photocopies of CVs, Registration certificates and numbers are required)

(k) Evidences of experiences of projects supervision in Nigerian Universities with project costs, level of completion and certificates of completion in the case of completed ones

(1) Evidence of knowledge of Terrain at the project location m. List of available software and equipment to be deploy on the scheme

(n) Sworn Affidavit attesting to the authenticity of information provided and that such information is true in every respect and that the firm is not in receivership and none of its Principal Partners has ever been convicted of fraudulent activity

(o) Evidence of Payment of Processing fee of N100,000.00 in bank draft in favour of" Federal University Wukari" to the University.

(p) Any relevant information that will be helpful in determining consultant's

suitability for the work.
