PRE-QUALIFICATION REQUIREMENTS:

Interested companies are to submit the following documents for pre-qualification and tender

- i. Incorporation registration with Corporate Affairs Commission (CAC)
- ii. Evidence of registration with Borno State Government as a Contractor and Ministry of Education.
- iii. Tax clearance certificate for last 3 years.
- iv. Company VAT Registration Certificate.
- v. Company profile and qualifications of some key officers of the organization.
- vi. A Letter of ability of perform from your bankers.
- vii. Evidence of similar job executed e.g. certificate of practical completion of projects undertaken.

NB: You are to come alone with your original copies of all documents attached for verification.

METHOD OF APPLICATION:

Interested companies are to submit pre-qualification documents: and if interested to tender, you can collect tender documents on payments of Twenty-five thousand naira (N25,000) non refundable fees and Twenty-five thousand naira (N25, 000) for registration with Ministry of Education as a contractor from the secretary Ministerial Tender Board, (Direct Planning Research and Statistics Ministry of Education).
