# 2.0 Pre-Qualification Requirements

- (iii) Evidence of Tax Clearance Certificate for the last three (3) years i.e 2011 -2013
- (iv) Company Audited Accounting the last three (3) years
- (v) Refundable bid security of 2% of bid sum in Bank Certified Cheque, (If applicable)
- (vi) A sworn affidavit that all documents submitted are genuine and verifiable

(vii) A sworn affidavit that none of its Directors has been convicted in any country for any criminal offence, including fraud or financial impropriety.

(viii) A sworn affidavit indicating whether or not any current officer of Ekiti State University, Ado-Ekiti is a former or present Director, shareholder or has any pecuniary interest in the company. (ix) Evidence of compliance with Part IV, section 16(6d)of the Public Procurement Act 2007 as it relates to Pension (Certification or exemption from PENCOM)

(x) Evidence of compliance with Section 6(ii) of the Industrial Training Fund (ITF) Amended Act, 2011.

(xi) Evidence of compliance with the Employee's Compensation Act which requires that all Employers of labour must remit 1% of the total annual emolument of their workers to the Nigerian Social Insurance Trust Fund.

(xii) Evidence of Registration for Value Added Tax and Remittances

Failure to provide a (i xii) above will automatically disqualify the bidder.

#### **B)** Other Requirements

- 1. List of verifiable Equipment owned(provide receipts, pictures etc)
- Evidence of Technical and Professional staff strength with Academic and Professional qualifications of Key personnel available for the project, Curriculum Vitae of Personnel to be duly authenticated by individual staff.
