**Invitation for Pre-Qualification and Tender Exercise of Contractors for Year 2013
Tertiary Education Trust Fund (TETFund)**

1.0 Introduction

In line with the requirements for due process for award of contracts for capital projects, the Ekiti State University, Ado-Ekiti wishes to invite competent/qualified Contractors to pre-qualify and tender for:

1. Construction and Furnishing of Faculty of Arts Building

2.0 Pre-Qualification Requirements

1. Interested contractors are invited to submit the following Compulsory and Mandatory documents:
 2. Evidence of Registration with Corporate Affairs Commission (CAC) including
 - ii. CAC registration form CO2 and CO7 containing list of Directors and Shareholders
 - iii. Evidence of Tax Clearance Certificate for the last three (3) years i.e. 2011-2013
 - iv. Company Audited Account in the last three (3) years i.e. 2011-2013
 - v. Refundable bid security of 2% of bid sum in Bank Certified Cheque.
 - vi. A sworn affidavit that all documents submitted are genuine and verifiable
 - vii. A sworn affidavit that none of its Directors has been convicted in any country for any criminal offence, including fraud or financial impropriety.
 1. A sworn affidavit indicating whether or not any current officer of Ekiti State University, Ado-Ekiti is a former or present Director, shareholder or has any pecuniary interest in the company.
 - ix. Evidence of compliance with Part IV, section 16 (6d) of the Public Procurement Act 2007 as it relates to Pension (Certification or exemption from PENCOM)

- x. Evidence of compliance with Section 6(ii) of the Industrial Training Fund (ITF) Amended Act, 2011.
- xi. Evidence of compliance with the Employee's Compensation Act which requires that all Employers of labour must remit 1% of the total annual emolument of their workers to the Nigerian Social Insurance Trust Fund.
- xii. Evidence of Registration for Value Added Tax and Remittances

Failure to provide a (i-xii) above will automatically disqualify the bidder.

1. Other Requirements

- 2. List of verifiable Equipment owned (provide receipts, pictures etc)
- 3. Evidence of Technical and Professional staff strength with Academic and Professional qualifications of Key personnel available for the project, Curriculum Vitae of Personnel to be duly authenticated by individual staff.
- 4. Evidence of relevant verifiable experience on similar jobs in Nigeria over the last 5 years stating location, cost and duration of execution, with letters of Award and Certificates of Completion.
- 5. Evidence of Social Responsibility in terms of Endowment, Sports or ETF contribution.
- 6. Reference letter from bankers and copies of current bank statements.

All requirements in 2a and b are to be arranged in the ORDER above

3.0. Verification of Claims

Interested contractors must note that Ekiti State University, Ado-Ekiti reserves the right to verify claims made in the pre-qualification document submitted by them.

4.0. Pre-Qualification and Tenders Fees

Contractor is to pay a non-refundable processing fee of N40, 000.00. The fee should be paid in Bank Draft and addressed to Ekiti State University, Ado-

Ekiti. 5.0. Submission of Documents

- 1. The pre-qualification applications with all the required supporting documents should be neatly packaged, bound and forwarded in sealed envelope and marked at the top

left corner. For example: “Pre-qualification for the **Construction and Furnishing of Faculty of Arts Building**

2. The completed tender’s document collected from Physical Planning Department, Ekiti State University, Ado-Ekiti, Room 025 Omolayo Administration Building must be sealed in an envelope marked at the left corner; “Tender documents for the **Construction and Furnishing of Faculty of Arts Building**”.

The companies submitting the pre-qualification and tender document should write the name, mobile phone number of contact person and the name of the Firm at the bottom left corner of the TWO envelopes. This will allow for prompt communication. The pre-qualification and tender document must reach the University not later than **9.00 a.m. on 24th July 2014.**
