- (h) Evidence of Pension Scheme for Company staff with evidence of payment.
- (i) Evidence of Compliance with industrial Training Fund Act 2011 (As Amended)
- (j) An affidavit disclosing whether or not any officer of the relevant committee of the Osun State College of Education, Ilesa or the Bureau of Public procurement is a former or present Director, shareholder or has any peculiar/ interest in the bidding company.
