**Lot. 1** Construction of water works for the College comprising of 6Nr. Borehole, Treatment Plant/Reticulation, Office/Generator House and Fence.

**Lot. 2** Rehabilitation/Equipping of Science Laboratory Complex comprising of Biology, Chemistry, Physics and Integrated Science.

**Lot.3** Supply and Commissioning of 2Nr. Hiaer USA Bus HLQ 6125A Auto Visual System Hiaer Bus.

**TECHNICAL AND FINANCIAL BID REQUIREMENTS**

To be considered, potential Contractors/Companies are required to submit all the under listed verifiable documents:

- (1) Evidence of Company registration with the Corporate Affairs Commission (CAC) and evidence of memorandum of understanding (MOU) in case of joint ventures to include names of Directors and shareholders.
- (2) Evidence of Tax Clearance Certificate for the last three years (2013-2015).
- (3) Company's Audited Account for the last three years duly stamp by registered Auditors (2013-2015)
- (4) Evidence of compliance with Pension Reform Act, 2014 by inclusion of clearance Certificate from National Pension Commission (PENCOM).
- (5) Evidence of compliance with the provision of Industrial Training Fund (ITF) Amendment Act by inclusion of Compliance Certificate from ITF.
- (6) Evidence of registration on Bureau of Public Procurement (BPP) National data base of Contractors, Consultant and service providers by inclusion of Interim Registration Report (IRR).

- (7) Evidence of Financial Capability and Banking support (Bank Reference from a reputable Bank).
- (8) Verifiable evidence of similar jobs successfully executed or being executed within the last three (3) years, indicating type, cost, location and evidence of award and completion Certificate.
- (9) List of names of key personnel to be involved in the project stating their qualification, year of cognate experience and professional registration where applicable (Enclose photocopy of credentials).
- (10) Evidence of fulfillment of the obligation to Social Security Contribution by inclusion of (NSITF) compliance Certificate.
- (11) Original Bank Statement for the past 12 months.
- (12) Original Copies of the documents would be requested to be made available for sighting whenever required.
