- (v) Company profile with details of key staff and equipment to be deployed for the proposed work
- (vi) Evidence of previous similar assignments with relevant evidence of successful completion.
- (vii) Evidence of compliance with TTF provisions
- (viii) Evidence of Compliance with Pencom provisions
- (ix) Bank reference letter containing financial status of the company.
