Invitation for Pre-Qualification and Tender for the Year 2013 TETFund Special Intervention Project

1.0 Introduction

The Kogi State College of Education, Ankpa, intends to undertake pre-qualification and tender exercises for the Year 2013 Special Intervention Projects at the College for the following projects:

2.0 Pre-Qualification Criteria

- (viii) List of similar jobs executed with evidence of names of Clients and Letters of Award;

- (ix) Evidence of financial capability and banking support; and
- (x) Any other document that will enhance the potential of the company.
