- (10) Evidence of fulfillment of the obligation to Social Security Contribution of Nigeria Social Insurance Trust Fund (NSITF) by inclusion of compliance Certificate.
- (11) Original Bank Statement for the past 12 months.
- (12) Original Copies of the documents would be requested to be made available for sighting whenever required.
- (13) The documents are to be arranged in the above other.
