- 11. Sworn Affidavit that none of the Director or Partners of the company has been “Convicted in any Country for any Criminal offences relating to fraud or financial impropriety”,
- 12. Sworn Affidavit indicting whether any Officer of Federal Polytechnic, Bauchi is a former or present Director, shareholder or has any pecuniary interest in the Company.
