- 9. Comprehensive company profile giving details of technical and administrative staff with evidence of their qualifications.
- 10. List of projects supervised within the last five (5) years, including letters of commission, cost and evidence of completion.
- 11. Reference to major projects giving names, addresses and telephone numbers of contact person from the clients.
- 12. Evidence of corporate social responsibility.
