Pre-Qualification Requirements:

- Evidence of registration with the Corporate Affairs Commission
- List and Resume of Management and Kay Staff (Technical) and photocopies of academic qualification certificates and evidence of registration with the relevant Professional Bodies
- Evidence of Registration with PENCUM
- Letter of Financial Reference from a reputable Bank and consent to allow for verification with Bankers.

- A declaration of e sworn affidavit that none of the Directors has been convicted in any court for any criminal offence inducting fraud or financial impropriety.
- Evidence of payment of Education Tax.
- Evidence of Tax Clearance Certificate for the last three (3) years
- Evidence of VAT registration and past VAT remittance
- Evidence of financial strength, credit worthiness and solvency (Reference Letter, Statement of Account e t.c).
- Evidence of Audited Accounts of the Company for the last three (3) years
- Evidence of similar projects successfully executed with their location (copies of letters of award, certificate of completion e.t.c. to be attached).
- Evidence of payment of appropriate non-refundable processing fee:
 - Lot 1: N100,000.00
 - Lot 2: 20,000.00
 - Lot 3: 20,000.00 at the Bursary Department

It should be submitted **not later than 28th November 2014.**
