- (iii) Evidence of Registration with PENCUM
- (iv) Letter of Financial Reference from a reputable Bank and consent to allow for verification with Bankers,
- (v) A declaration of a sworn affidavit that none of the Directors has been convicted in any court for any criminal offence including fraud or financial impropriety.
- (vi) Evidence of payment of Education Tax.

(vii) Evidence of Tax clearance certificate in the last three (3) years.

(viii) Evidence of VAT registration and past VAT remittance.

(ix) Evidence of financial strength, credit worthiness and solvency (Reference Letter, Statement of Account etc).

(x) Evidence of Audited Accounts of the Company in the last three (3) years, (xi) Evidence of similar projects successfully executed with their location
