- v. Evidence of financial capability and possible bank support
- vi. Recent Three (3) Years Tax clearance Certificates
- vii. Evidence of compliance with the Industrial Training Fund (ITF) Act 2011 (Amended)

4. Submission of Pre-Qualification Documents:

Bound Pre-qualification documents should be submitted in a sealed envelope marked “Pre-qualification document for.....” addressed to the Head of the Procurement Unit, Federal University, Kashere, Gombe State.

5. Opening of Pre-Qualification Documents:

Pre-qualification envelopes will be opened on 30th April, 2014 at 12 noon at the University Conference Room. All bidders or their representatives and NGOs are invited to witness the opening exercise.

Only pre-qualified Contractors/Suppliers shall be invited to send in their financial bids upon payment of non-refundable tender and processing fee of Twenty Thousand Naira (N20,000.00) only.
