The College is desirous of undertaking a pre-qualification and tender exercise for the under listed projects under the TETfund intervention projects. Consequently, the College wishes to invite reputable Contractors/Companies to submit technical and financial bids for the following projects:

Lot-1 Construction/Expansion of 2-story Building comprising of 16Nr. Office Block. 8Nr, Classroom, 4Nr. Lecture Hall and Toilets for Block E and F including External works.

Lot.2 Construction of 2-story Building comprising of 28Nr, Office Block, 4Nr. Lecture Hall and 2Nr. Examination Hall and Toilet for Mopol Block including External works

Lot.3 Construction/Expansion of 2-story Building comprising of 24Nr. Office Block and Toilet for Mathematics Lecture is including External works.

Lot.4 Construction/Expansion of 2-story Building comprising of 24Nr. Office Block and Toilet for Remedial Block including External works

TECHNICAL AND FINANCIAL BID REQUIREMENTS

To be considered, potential Contractors/Companies are required to submit all the under listed verifiable documents:

- (1) Evidence of Company registration with the Corporate Affairs Commission (CAC) and evidence of memorandum of undemanding (MOU) in case of joint ventures to include names of Directors and shareholders.
- (2) Evidence of Tax Clearance Certificate for the last three years (2013-2015).
- (3) Company's Audited Account for the last three years duly stamp by registered Auditors (2013-2015)
- (4) Evidence of compliance with Pension Reform Act, 2014 by inclusion of clearance Certificate from National Pension Commission (PENCOM).
- (5) Evidence of compliance with the provision of Industrial Training fund (ITF) Amendment Act by inclusion of Compliance Certificate from ITF.
- (6) Evidence of registration on Bureau of Public Procurement (BPP) National data base of Contractors, Consultant and set vice providers by inclusion of Interim Registration Report (IRR).

- (7) Evidence of Financial Capability and Banking support (Bank Reference from a reputable Bank).
- (8) Verifiable evidence of similar jobs successfully executed or being executed within the last three (3) years, indicating type, cost, location and evidence of award and completion Certificate.
- (9) List of names of key personnel to be involved in the project stating their qualification, year of cognate experience and professional registration where applicable (Enclose photocopy of credentials).
- (10) Evidence of fulfilment of the obligation to Social Security Contribution by inclusion of (NSITF) compliance Certificate.
- (11) Original Bank Statement for the past 12 months.
- (12) Original Copies of the documents would be requested to be made available for sighting whenever required.

SUBMISSION OF PRE-QUALIFICATION AND TENDER DOCUMENTS

The pre-qualification and tender documents should be submitted sealed and clearly marked "**Pre-qualification and tender document for.....**(quote me appropriate project name boldly stated) and deposited in the **Office of the Registrar, Federal College of Education, Zaria to reach him latest by 12:00pm on 28th December, 2016** with the payment N15.000.00 (Fifteen Thousand Naira Only) non-refundable Tender fee.

- (1) All pre-qualification documents shall be tendered in English and spiral bound.
- (2) Fake/Suspicious document attract disqualification and maybe handed over to the appropriate government agencies (or necessary action).
