- f. List of key personnel to be involved in the project(s) stating their qualification and registration with relevant professional bodies where applicable (include photocopies of credentials).

- g. List of plans and equipment to be used for the project(s).
- h. Annual turn-over of the company.
- i. Evidence of compliance with requirements for pension Act. 2004.
- j. VAT registration and evidence of past- VAT remittances.
- k. Originals of documents (a and b) must be produced for sighting.
