# (A) Description of the Works

The project shall consist of the construction of two prototypes faculty blocks three wings comprising of lecture theatre, storey complex (ground floor and one upper floor) and (ground floors). While the procurement of laboratory and workshop equipment comprises supply, installation and maintenance of existing equipment, you are also advised to see the equipment to be maintained before bidding. The equipment and buildings are as detailed in the bills of quantities.

(ix) List of similar projects previously/currently undertaken including letter of awards, completion certificates, period of supply and project costs.

### (C) Collection of Pre-Qualification Document

Interested contractors are required to pay a non-refundable processing fee (bank draft) of N100,000.00 (One Hundred Thousand Naira Only) for Lot A and Lot B while N50,000.00 (Fifty Thousand Naira Only) for Lot C at the Bursary department of the University. The drafts should be made payable to the Bursar, Niger Delta University, Wilberforce Island.

A receipt shall be issued which will then enable the bidder to pick up bid documents at the office of the Director, Physical Planning, Niger Delta University, between the **hours** of **9.00am and 3.00pm**, from the date of this publication.
