- g. Evidence of Registration of Financial Regulatory Council
- h. Evidence of Financial capability and banking support
- i. Evidence of SIMILAR & verifiable projects executed not just awarded within the last five years.
- j. Annual turnover.
- k. Evidence of VAT registration
- l. Comprehensive *Company* profile and organizational structure.
- m. Evidence of equipments and technology capacity.
- n. Evidence of Experience /Technical qualification and experience of key personnel and their professional certificate,
- o. Sworn Affidavit to indicate that all information provided are true in every respect that the company is not in receivership and none of its Directors were ever convicted of fraudulent activity,
- p. Sighting of original copies of all the documents listed in the profile must be presented during opening of bids

q. Payment of Non-Refundable fee of Twenty Five Thousand Naira (N25, 000:00) only.
