- (iii) Evidence of Current Pension Clearance Certificate based on the PENCOR Reform Act 2014.
- (iv) Evidence of Current Nigeria Social Insurance Trust Fund (NSIT) clearance certificate.

- (v) Evidence of compliance with Financial Reporting Council of Nigeria (FRCN) Act No. 6 (2011).
- (vi) Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPC) to confirm registration as a contractor on the National Database
- (vii) Verifiable Evidence of financial capability with an average annual turnover of not less than N70million in me last three years (2013, 2014 & 2015).
- (viii) Evidence of current ITF Certificate in compliance with Industrial Trust Fund (ITF) Act, 2005.
- (ix) Current sworn affidavit disclosing:
 - (a) That the company is not in receivership, insolvent or bankrupt
 - (b) That the company does not have any Director who has ever being convicted in any court in Nigeria or any other country for criminal offence in relation to fraud or financial impropriety.
 - (c) Whether or not any officer of Federal Ministry of Education/Federal Government College, Ilorin is a former or present Director, Shareholder or has an pecuniary interest in the bidder.
 - (d) That all document submitted for the bidding are true and correct.
- (x) List and verifiable documentary evidence of at least two (2) similar jobs successfully executed within the last five (5) years including letters of awards and job completed certificates.
- (xi) List of key technical personnel indicating their roles, designation, qualification certificate and years of experience with the guarantee that a minimum of three (3) relevant registered professional shall be deployed on the project.

- (ii) Contractors are not permitted to bid for more than one lot and violator shall be disqualified.
- (iii) Submission outside the requirement specifications above shall be rejected.
