- (6) Verifiable list of similar jobs successfully executed in the last 3 years, including Letter of Award of contracts, Project Cost, Completion Certificates and payments

- (7) Sworn Affidavit indicating the authenticity of information provided in every respect that the company is not in receivership and none of its Directors were ever convicted of fraudulent activity
- (8) Evidence of compliance with the provision of the Industrial Training Fund Amendment Act as stipulated in Section 6 (1)-(3),
- (9) Evidence of compliance with Pension Reform Act and up to date remittance of employees' pension fund contribution in line with section 6 d of the Public Procurement Act, 2007
- (10) Company Profile to include among others, Office Address, Current Telephone Numbers and e-mail address and evidence of technical and professional qualification(s)
- (11) Equipment and Technology capacity
- (12) Bidders should indicate the job category they intend to bid for.
- (13) Any other relevant information that will be helpful in determining the company's suitability for the work.

(C) Payment of Tender Fee

Bidders are to pay a non-refundable fee of N25.000 for each Lot to FGC Okposi, Treasury Single Account (TSA) via www.remitta.net
