The Project includes the construction of and furniture supply for Primary Schools in Oyo State and intends to apply a part of the Grant to eligible payments under the contract for CMNG14-001.

Japan International Cooperation System (JICS) (hereinafter referred to as "**the Employer**") acts for and on behalf of the Recipient to procure the products and services in accordance with the E/N and the G/A. The Employer is also delegated to conclude a contract with the contractor and to make a payment to the contractor.
