1. Submission of Bidding Requirements

- Current Tax Clearance Certificate for the last three (3) years (2011, 2012, and 2013 to expire in 2014).
- Evidence of VAT registration and Remittances.
- Evidence of compliance with Pension Reform Act 2004.
- Evidence of compliance with the provision of Industrial Training Fund (ITF) Act 2011 as amended.
- Evidence of compliance with NSITF (1 %) employees Compensation Act.
- Detailed Company profile, organizational structure; including names and curriculum Vitae of Key Staff as well as their addresses and individual attestation of availability of specialized and expertise in consultancy project of similar nature.
- Three year Audited Account (2011, 2012, 2013).
- A sworn affidavit that none of the Directors has been convicted in any court of law for any criminal offence.
- Evidence of financial strength and credit worthiness supported by a letter of reference from your bank and accompanied with bank statement for the last six (6) months.
- For joint venture, Memorandum of Understanding should be provided.
- Evidence of verifiable previous experience including letters of award and completion certificates.
- Name, e-mail address and telephone numbers of contact persons for the previous jobs undertaken.

2. Collection of Tender Documents
