- i.) Verifiable evidence of at least five (5 Nos.) similar projects handled in the last seven
 (7) years (indicating the clients, contract value and location of the projects with evidence of completion certificates or IPCs, if on-going);
- j.) Evidence of compliance with the ITF Amendment Act, 2011 by including the Letter of Compliance from the Industrial Training Fund;
- k.) Evidence of compliance with Pension Reform Act, 2004 by including the Letter of Compliance from the National Pension Commission;
