1.0 Introduction

One of the cardinal policy of the Sen. Prof. Ben Ayade's led administration is the achievement of Universal Health coverage with provision of quality health care at the grassroot through the revitalization of the Primary Health Care system in the State, which serves over 80% of the population in Cross River State.

This is in line with the National Policy on Primary Health and the Governor's resolve to have at least one functional comprehensive health centre in every local government area and one functional PHC in every ward in the state, to improve the implementation of Ayadecare which is the State Health Insurance Scheme. In light of the above, eligible contractors/vendors with the requisite technical and financial knowhow In similar jobs/project are requested to bid/tender for the Construction of a comprehensive healthcare centre/staff quarters/perimeter fence and procurement of medical equipment in Uchu Yache, Yala Local Government Area.

2.0 SCOPE OF WORKS/SERVICES

Design and the construction of a Comprehensive Health Care Centre/Staff Quarter/Perimeter Fence and the procurement of Medical Equipment sub-divided into (3) LOTS.

LOT 1: Design and construction of a Comprehensive Health Centre

LOT 2: Design and construct a semi-detached (3) in one bedroom staff quarters and perimeter fencing

LOT 3: Procurement of Medical Equipment
