(A) Tendering shall be conducted through the National Competitive bidding specified in the Procurement Act 2007 and is open to all interested Contractors.

(B) Tendered

Qualifications/Requirements:-

- (1) A Comprehensive Company profile with CVs of key officers including photocopies of relevant professional/technical qualifications
- (2) Evidence of Registration with Corporate Affairs Commission.
- (3) Evidence of Registration and Certificate with Industrial Training Fund
- (4) Current three (3years) Tax Clearance ending December 2014
- (5) Evidence of similar jobs executed by the Company
- (6) Evidence of VAT Payment (VAT Certificate and TIN NO)
- (7) Evidence of Financial Capability to execute the projects
- (8) Evidence of Qualified Technical and Professional Staff

(9) Certificate of Compliance, Pension clearance and remittals to all Organisation by National Pension Commission in line with Pension Reform Act 2004 (as amended).

(10) Sworn Affidavit disclosing whether or not any officer of FGC, Idoani has any pecuniary interest in the company and that information presented in its bid are true.

(11) Bidders shall not bid for more than two (2) Lots

N.B The above listed requirement shall form part of the bids Evaluation criteria and non-compliance with any of the stated conditions shall result in automatic disqualification of the bidder)

(c) The two (2) envelope in (a) and (b) are sealed in a Single Large Envelope and marked LOT NO.....and addressed to The Principal. Federal Government College, Idoani, Ondo State **not later than 12 noon Friday 4th December, 2015.** All submissions must reach the College before the closing date.
