#### (3.0) METHOD OF APPLICATION

Interested Tenderers are to submit a comprehensive company profile, paged with a table of content, using coloured labelled separators, to include the under listed requirements and arranged in the under listed order. The requirements include, among others.

- (a) A signed letter of application for the Project of interest.
- (b) Evidence of Company Certificate of Incorporation from Corporate Affairs Commission (CAC) including a copy of Form 02 and 07 with Articles of Association.
- (c) Company Tax Clearance certificate for at least three (3) years (2015, 2014 and 2013) expiring on December 2016 with Tax Identification Number (TIN)
- (d) Current Certificate of Compliance with PENCOM Act
- (e) Current Certificate of Compliance with Industrial Training Fund (ITF) Act

- (f) Evidence of Certificate of Compliance with National Social Insurance Trust Fund (NSITF) in line with Section 16 of the Public Procurement Act 2007.
- (g) Sworn Affidavit in line with the provisions of Part IV, section 16, sub-section 6(f) of the Public Procurement Act 2007 that all documents submitted are not only correct but genuine and to include among others;
- (1) That the Director(s) of the prospective contractual company has/have never been convicted by any Court of Law.
- (2) That neither the company nor any of the company's directors is bankrupt.
- (3) That none of the officers of UNIUYO, FEDERAL MINISTRY OF EDUCATION or BPP is a former or present director/staff of the Company.
- (4) That the company is not in receivership.
- (h) Evidence of Registration on the National Data Base of Contractors, Consultant and Service Providers by inclusion of Interim Registration Report issued by the Bureau of Public Procurement (BPP)
- (i) A signed letter authorizing University of Uyo, Uyo, to verify from relevant Agencies and bodies claims made on your submissions.
- (j) Names/functional e-mail addresses and phone numbers of Company's key contact persons and that of persons to be assigned on the project if awarded to your Company.
- (k) Company's Organisational structure.
- (I) Completed, signed and sealed Tenderers Information Sheet (Form W-2) reproduced from Bureau of Public Procurement (BPP) Standard Bid Documents as contained in the Tender Bid Document.
- (m) List of Technical Staff to be deployed on the project should include 1No. each of Architects, Structural Engineer, Electrical Engineer, Mechanical Engineer, Quantity Surveyor and Builder who shall submit the following:
- (1) Signed CV's by staff with passport photographs, both endorsed at the back by Chief Executives of the Company

- (2) Evidence of Full Membership Registration Certificate with the Relevant Regulatory Body in Nigeria
- (3) Relevant Current Practice License
- (n) Evidence of 3Nos. verifiable similar jobs successfully executed or on-going within the past ten (10) years. Include the client's letters of awards, stating original contract sum of project, reviewed contract sums, year of commencement/completion, original contract completion period, photocopies of completion Certificate(s) and Interim Payment Certificates (IPC's), if work is on-going. State causes of delays, if any, amongst other relevant information.
- (o) List of relevant equipment and tools owned, properly categorized under general, mechanical and electrical. (Provide evidence of ownership and or current lease agreement). Ownership of verifiable batch plant/yard for concrete works, metal scaffolding, metal formworks, crane(s) and block molding equipment, will added advantage.
- (p) Evidence of financial capability
- (i) Line of credit from bank
- (ii) Current bank statement within the last twelve (12) months.
- (iii) Reasonable liquid assets and annual turnover (Annual Turn Over for project to comply with BPP's requirements).
- (q) Company's audited accounts for year 2015, 2014 and 2013, duly endorsed by Chartered Accountant with Stamp.
- (r) Any other relevant information that will be helpful in determining the bidder's suitability for the works.

Joint ventures can submit a single application per project or lot, but must state the lead partner in the project. The lead partner shall have at least 60% of the verifiable similar jobs submitted. Joint ventures shall include their Memorandum of Understanding properly signed by both parties; each party shall submit ail the requirements on the list as required in the advert.

**NOTE:-** Tenderers should complete the Tenderers Information Sheet (Form W-2) of Bureau of Public Procurement (BPP) Standard Bid Documents in the Financial Bid document. The form

should be reproduced and attached to the Technical Bid document, as part of the submission requirements.

Applicants may indicate interest in more than one (1No) Project but each must be applied for separately with all relevant requirements met. Tenderers shall not be awarded more than one project under Year 2013 Needs Assessment Intervention Fund for Nigerian Public Universities (Batch 2).

### (4.0) METHOD OF PAYMENT FOR TENDER DOCUMENTS:

The non-refundable fee sum of Ten Thousand Naira (\text{\text{\$\frac{4}}}10,000.00) only per project, shall be paid to the Bursary Department and the receipt submitted to the Procurement Unit, Office of the Vice-Chancellor, Ground Floor, Left Wing, Central Administration Building, Main Campus, University of Uyo, along Nwaniba Road, Uyo, for collection of the Tender Documents. Drawings shall not be issued but shall be available for sighting at the point of collecting the Tender Documents.

**NOTE:-** Tenderers who had earlier responded to our advert of Monday, December 8, 2014 on Year 2013 TETFund Needs Assessment Special Presidential Intervention (Batch 2), and paid a non-refundable fee of Ten Thousand Naira (\htimes10,000.00) only per project, need not pay again but shall be required to present evidence of earlier payment.
