- (6) Verifiable of registration with the Bureau of Public Procurement (BPP) Federal contractors, consultants and suppliers Database
- (7) Verifiable evidence of financial support from a reputable Bank
- (8) Verifiable evidence of letters of awards and job completion certificates of previous experience in similar join(s) at least three (3) in the last five years.
- (9) Verifiable evidence of construction equipment with proof of ownership or lease agreement
- (10) Verifiable evidence of payment of a non-refundable tenders fee of N20,000.00

(11) Verifiable evidence of company profile and technical qualification of Key personnel with registration with relevant professional bodies
