(1.0) Introduction

The Nigerian National Petroleum Corporation ("NNPC") is in the process of carrying out Rehabilitation of Crude oil charge Heater (10H01) in Kaduna Refining and Petrochemical Company (KRPC) so as to improve Production and capacity Utilization of the Plant.

Kaduna Refining and Petrochemical Company (KRPC) has Heaters attached to the various units according to need and usage. Crude Distillation Unit (CDU-1) is one out of the various units which is designed to process Nigerian Crude oil that is Naphthenic in nature. Crude Oil Charge Heaters are critical equipment to KRPC'S 110,000 BPSD operation.

The Crude Oil Charge Heater (10H01) is attached to this unit to aid in bringing up the temperature to the level desired to achieve efficient distillation process.

The performance of this Heater has deteriorated over the years as a result of the poor state of its refractory. The need to improve plant capacity utilization to meet the ever-increasing local demand for Premium Motor Spirit (PMS) and other petroleum products has made it imperative to rehabilitate the Crude Oil Charge Heater (10H01). This measure will go a long way to significantly improve production and capacity utilization in KRPC.
