- (11) An affidavit disclosing whether or not any Officer of the relevant Committees or staff of the Institute of Management and Technology (IMT), Enugu or staff of the Institute of Management and Technology (IMT), Enugu or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the Company, and confirming that all the information it presented in its pre-qualification documents are true and correct.
- (12) Sworn Affidavit in respect of non-affiliation to any staff of the institute of Management and Technology (IMT), Enugu and that no Director of the Company is bankrupt.
- (13) Evidence of remittance of pension contribution of employees to PENCOM in line with section 16 subsection 8 (D) of the procurement Act.
- (14) Evidence of compliance with the provisions of the Industrial training Fund Amendment Act 2011 in respect of contribution to the Fund where applicable.
