#### **ELIGIBILITY REQUIREMENTS**

- (a) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Forms CAC 1.1.or CAC2 and CAC 7;
- (b) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31st December, 2021; with minimum average turnover of N100millon for construction work while N 10 million for procurement.
- (c) Evidence of current Pension Compliance Certificate valid till 31st December, 2021;
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2021;
- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2021;
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31st December 2021 or valid Certificate issued by BPP.

- (g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the (Kwara State University, Malete, Kwara State) or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- (h) Company's Audited Accounts for the last three (3) years 2018, 2019, 2020;
- (i) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- (j) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (In case of construction: COREN, QSRBN, ARCON CORBON etc.);
- (k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (s) years including Letters of Award, Job Completion Certificates and Photographs of the projects;
- (I) List of Plants/Equipment with proof of Ownership/Lease (where applicable)
- (m) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letterhead Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.) and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page. Duly signed by the authorized officer of the firms.

Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to The Registrar, office of the Registrar, Kwara State University, Malete and clearly marked with the name of the project and the Lot number. Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and dropped in the designated Tender Box at the office of the Registrar, Kwara State University, Malete not later than 12:00 noon, 9 January, 2022.

# (6) OPENING OF BIDS

The technical bids will be opened immediately after the deadline for submission at 12:00 noon 9 January, 2022 in the Council Chamber of Kwara State University, Malete in the presence of bidders or their representatives, while the financial bids will be kept un-opened.
