# (4) NIGERIAN CONTENT

Mobil Producing Nigeria Unlimited (MPN) is committed to the development of the Nigerian oil and gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian oil and gas Industry shall be consistent with the level set in the Schedule to the Act and any other targets as may he directed by the Nigerian Content Development and Monitoring Board (NCDMB).

NNPC/MPN JV requires their contractors to comply with the Act, its attached Schedule and any applicable regulation developed by the NCDMB.

Nigerian Content in the Nigerian oil and gas industry is defined as:

The quantum of composite value added to or created in the Nigerian economy by a systematic development of capacity and capabilities through the deliberate utilization of Nigerian human, material resources and services in the Nigerian oil and gas industry.

Nigerian company is a company formed and registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

## As part of their submissions. Tenderers shall:

(1) Provide a description of its committed infrastructure (asset, equipment, technical and administrative office(s), inspection tools, etc.) in Nigeria to support this contract.

(2) Demonstrate that its entity is a Nigerian registered company with greater than or equal to 51% Nigerian shareholding. Provide details of its Ownership Structure. Submit certified true copies of CAC form (C02 and C07) and evidence of registration with N0GIC JQS.

(3) Submit a plan on how it intends to give first consideration to goods and services provided from within Nigeria, to meet NC targets for the various phases of the project in line with the requirements of the NOGICD Act.

(4) Demonstrate Key Management positions that are Nigerian Nationals and the percentage of the company total work force (direct and in-direct employees that are Nigerians.

(5) Tenderer shall provide evidence of category C NCEC and or category 1, 2, 3 or 4 NCEC in construction and moveable equipment category to demonstrate capacity & capability to execute the work scope.

(6) Tenderer shall procure all consumables not limited to MV and LV cables, switch gears, panels, civil materials etc, from a local manufacturing vendor with a valid category A NCEC and or category 1, 2,3,4 or 5 NCEC in manufacturing and other related services group (MS).

All HV cables shall only be procured from in-country manufacturers having current production capacity for HV cables.

Tenderer's failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content development will result in bidder's disqualification.

# (5) CLOSING DATE

Only tenderers who are registered in the NJQS product category: 4.05.12 (Power Generation and Transmission-IPP Distribution and Transmission) and 3.11.12 (Information System (IS) / Information Technology (IT) Services) as at **January 21**, **2022** being the advert closing date shall be invited to submit Technical Bids.
