- (iii) Construction of blocks of 4 classrooms
- (iv) Construction of Storey block of 8 classrooms with Offices
- (v) Construction of Perimeter Fence, Gate and Gatehouse
- (vi) Construction of a block of 4 compartment toilets (Water system)
- (vii) Geophysical Surveys for Boreholes

- (c) Evidence of Recent Company's Income Tax Clearance Certificate
- (d) Registration as a contractor with the Nasarawa SUBEB
- (e) Verifiable evidence of similar Jobs handled in the last 3 years (Award and Completion Letters in the relevant area of interest for the year 2018, 2019 and 2020) For Furniture, company to include factory location.
- (f) PenCom Certificate
- (g) Industrial Training Fund (ITF)
- (h) Interim Registration Report from Bureau of Public Procurement, BPP
