(1) INTRODUCTION

(3) ELIGIBILITY REQUIREMENTS

Interested Firms/Companies should submit the following verifiable Pre-Qualification Documents:

- (i) Evidence of Certificate of Incorporation issued by the Corporate Affairs Commission (CAC) including Form CAC 1.1 or CAC2 and CAC7;
- (ii) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31st December, 2022; with minimum average annual turnover as stated in the bid documents;
- (iii) Evidence of Pension Clearance Certificate valid till 31st December, 2022 (this requirement is only applicable to bidders whose number of staff is 15 and above);
- (iv) Evidence of Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2022 (this requirement is only applicable to bidders whose number of staff is 5 and above or the bidder's annual turnover is N50m and above);
- (v) Evidence of Nigeria Social Insurance Trust Fund (NSITF) Clearance Certificate valid till 31st December, 2022;
- (vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31st December, 2022 or valid Certificate issued by BPP;
- (vii) Sworn Affidavit:
- disclosing whether or not any officer of the relevant committees of the National Business and Technical Examinations Board or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- indicating whether the Company is/is not in receivership, insolvent or bankrupt
- must not have any Director who has been convicted in any Country for any criminal offenses relating to fraud or financial impropriety

- (viii) Company's Audited Accounts for the last three (3) years 2019, 2020 & 2021, duly acknowledged by the Federal Inland Revenue Service (FIRS);
- (ix) Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- (x) Company's Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications such as COREN, QSRBN, ARCON, CORBON etc.;
- (xi) Verifiable documentary evidence of at least three (3) similar Jobs executed In the last five (5) years Including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;
- (xii) List of Plants/Equipment with proof of Ownership/Lease (where applicable);
- (xiii) LOT 1: Evidence of Firm's current registration with Renewable Energy Association of Nigeria (REAN) or its equivalent;
- (xiv) LOT 2 & 3: Only companies included in the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorized representatives should bid for the vehicles;
- (xv) Lot 4: Evidence of current registration/accreditation with Computer Professionals Registration Council of Nigeria and National Information Technology Development Agency (NITDA);
- (xvi) Category B: Evidence of Letter of Authorization as representative of the Original Equipment Manufacturers (OEMs);
- (xvii) All documents for submission must be transmitted with a Covering/ Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as Issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(4) COLLECTION OF TENDER DOCUMENTS (CATEGORY A)

Interested bidders should collect Standard Bid Documents from the Procurement Department on evidence of payment of non-refundable tender fee of N10,000 per Lot, into the NABTEB's TSA in any reputable Commercial Bank in Nigeria.

(5) SUBMISSION OF TENDER DOCUMENTS (CATEGORY A)

(5.1) Prospective bidders are to submit bid for each of the LOT desired, two (2) bound hard copies each of the Technical and Financial bids separated by dividers and arranged as indicated above and dearly marked as "Technical Bid or "Financial Bid". The documents should be submitted in a sealed envelope and addressed to:

(6.1) Prospective bidders are to submit pre-qualification documents for Category B, two (2) bound hard copies of the Technical bids, arranged as indicated above and dearly marked as "Pre-Qualification". The documents should be submitted in a sealed envelope and addressed to:

- (6.3) Please, note that contractor should not submit for more than One (1) LOT.

- (7.1) EOI & PRE-QUALIFICATION: The pre-qualification documents will be opened immediately after the deadline for submission at **12:00 noon Monday**, **16 May**, **2022** at the Board Room, NABTEB, National Headquarters, Ikpoba-Hill, Benin City, Edo State.
- (7.2) INVITATION TO TENDERS: Only the technical bids will be opened immediately after the deadline for submission at **12:00 noon Monday**, **16 May**, **2022** at the Board Room, NABTEB, National Headquarters, Ikpoba-Hill, Benin City, Edo State, while the financial bids will be kept un-opened;

(8.0) GENERAL INFORMATION

- (a) Bids must be in English Language and signed by an official authorised by the bidder;
- (b) Bids submitted after the deadline for submission would be returned un-opened;
- (c) All costs will be borne by the bidders;
- (d) Presence of bidders/representatives and members of the public shall not be required during the bid opening ceremony in compliance with COVID-19 Guidelines. The Bids Opening will be covered by video recording (invitation link will be sent to bidders to join the bid opening online) with the physical presents of two (2) representatives of private sector professional bodies and Civil Society Organisation in the areas of Anti-Corruption/Transparency;
- (e) Bid documents can also be collected in soft copies and Bidders can submit through Post (Courier Services);

- (f) Prequalification: Only pre-qualified bidders at technical evaluation will be Invited at a later date for collection of Tender documents;
- (g) EOI: Only shortlisted firms will be Invited at a later date for collection of Request for Proposals;
- (h) Invitation to Tender: Only pre-qualified bidders at technical evaluation will be invited at a later date for virtual financial openings while the financial bids of un-successful bidders will be returned un-opened;
- (i) The NABTEB is not bound to pre-qualify/shortlist any bidder and reserves the right to annul the Procurement process at any time without incurring any liabilities in accordance with Section 28 of the Public Procurement Act 2007
