  - (x) Evidence of Firm's current registration with the Council for the Regulation of Engineering in Nigeria (COREIN) by attaching current annual practicing license for the firm:
  - (xi) Detailed company profile to include Memorandum and Article of Association with Curriculum Vitae of key personnel's to be deployed for the project, including copies of their Academic/Professional qualifications; &
  - (xii) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.
